

**Canadian Tri-Services Emergency Management Committee
Annual Report August 15, 2015**

Committee Mandate:

This committee exists to champion integrated, interoperable and unified emergency management:

- Through formal relationships with police, fire and paramedic services (CACP / CAFC / PCC);
- In consultation and collaboration with other emergency management partners and agencies;
- By promoting and providing tri-services' input in support of the emergency management framework for Canada and associated strategies and action plans; and
- Based on an 'all hazards' approach that addresses the prevention, mitigation, preparedness, response and recovery pillars of emergency management.

COMMITTEE PRIORITIES:

- Serving as a conduit to recognized sources on emergency management related research, policy, plans and standards.
- Promoting interoperability and alignment amongst the tri-services, in collaboration with other emergency management partners and committees.
- Exploring tri-service training opportunities and requirements to enhance emergency management capabilities and capacity.
- Engaging with other emergency management partners and agencies across Canada to pursue opportunities for synergy across the broader responder community.
- Examining federal, provincial/territorial, and municipal emergency management legislative and policy issues, and to provide informed tri-service recommendations on critical and emerging issues.
- Improving understanding of the current state of Canadian emergency management

2014/15 Priorities:

1. To develop and execute a Tri-Service EM Committee strategy to highlight the ongoing work and successes of the committee)
2. To host a national EM conference in 2015/16.

Message/Executive Summary

The CTSEMC continues to play an important role in facilitating responders' dialogue with Public Safety Canada and SOREM; advocating for the needs of first responders on emergency and disaster response concerns. The need still exists to advocate for the long-term economic sustainability of emergency management training, processes and assets.

A strong ICS/IMS governance model is required on a national basis. The Transport Canada Emergency Response Task Force (ERTF) which was formed in the wake of the Lac Megantic rail disaster also noted a lack of national standards and consistency in emergency response systems. The availability of national standardized training capacities for responders remains of significant concern to the CTSEMC.

Achieving interoperability within, and amongst various agencies and governance levels, remains on the committee's agenda.

The Canadian Tri-Services Emergency Management Committee:

Governed by the three national Chiefs Associations through their designated co-chairs and supported administratively by CITIG, the CTSEMC is dedicated to strategic level, functional interoperability amongst first responders across Canada.

The Committee serves a unique niche focusing on national emergency management issues relevant to first responders from the tri-services. It allows a national voice to issues that first responders who operate predominantly at the municipal level, do not usually have access to. It provides an opportunity for members to (informally) communicate directly with Public Safety Canada and vice versa, each contributing its perspectives outside the confines of constitutional provincial mandates. The CTSEMC also affords a unified conduit to available research initiatives, such as offered by the Centre for Security Science's (CSS) Communities of Practice.

The necessity still exists to advocate for the long-term, economic sustainability of emergency management training and assets; such as incident management systems, the Recommended Equipment List, the Targeted Capabilities List (Capabilities Based Planning), HUSAR and CBRNE training, etc.

Challenges still persist on ensuring voices are heard from the municipal level of Emergency Responders on initiatives that impact them directly. CBRNE training is one example of this, whereby there has been no representation by Municipal Emergency Responders on F/P/T working groups

Committee Highlights and Activities:

1. The co-chairs participated in a panel discussion entitled The Canadian Tri-Services Emergency Management Committee & Responders' Risks, at the CRHNET 11th Annual Symposium in Toronto, in October 2014. This event provided an opportunity to inform the broader emergency management academic and practitioner communities of the committee's history, mission, priorities and activities. In addition, current concerns facing first responders in their goals to collaborate, coordinate and cooperate across the country were also discussed. Challenges such as operational planning (capabilities based planning and recommended equipment lists), implementing incident management systems, and achieving interoperability were all covered.
2. Thanks to committee member Dr. Kabilan Satyamoorthy, the CTSEMC Linked In page hosts many emergency management discussion topics.
3. Attended in support of the Eighth Canadian Public Safety Interoperability Workshop (CITIG 8 in Ottawa, Ontario on November 29th-30th, 2014).
4. Participation on the Transport Canada Task Force on Emergency Response, established in the wake of the Lac Megantic rail disaster. The group's primary focus being response to emergencies resulting from the rail transport of flammable liquids.
5. Partnered with Motorola Solutions in presenting the 2015 CACP/Motorola Emergency Preparedness Awards by judging the submissions and facilitating the awards process.
